03/05/2001 being no.1486 for the year 2001 referred to as the Principal Deed and thereafter its subsequent amendments and the said Trust is still in existence. The Deeds were created for the ends of intents and its purpose and subject to the powers and provision therein contained.

4.1 **Further Resolution:** It has been further resolute and/or resolved vide resolution dated 29.07.2015 that the New Trustees took over the charge of liabilities and/or Responsibilities and/or movable and immovable assets of the Said Trust in place of the Retiring Trustees namely Sri Jayanta Kumar Kumar Biswas, Sri Jhilik Biswas and Tarun Kumar Ghosh after considering their resignation/retirement from the said Trust forever.

4.2 **Purpose of Amendment:** Keeping the clauses in force as mentioned in the earlier Trust being registered as BGD Memorial Trust being No. 1486 for the year 2001 and subsequent Amendments in the Deed of Trust, The Board of Trustees vide their resolution dated 29.7.2015 firstly have appointed new Trustees by inserting some new names as Trustees for the interest of the existing Trust "BGD Memorial Trust" after been unanimous induction of New Trustees and on the second phase of said resolution Sri Jayanta Kumar Biswas and Sri Jhilik Biswas put resignation letters that was received by the House and subsequently in compliance of the clause/provision as embodied in the Trust Deed, those resignations have been accepted unanimously by the Board of Trustees.


5. **Ceased as Trustee:**

5.1 **Ceased:** As per the Principal Deed of BGD memorial Trust through their resolution dated 10.8.2003 had expelled and/or ceased one of its Trustees namely Rakesh Dani from the BGD Memorial Trust. Subsequently Sri Jayanta Kumar Biswas, Sri Jhilik Biswas and Sri Tarun Kumar Ghosh have been resigned as Trustee from the BGD Memorial Trust and their resignation letters have been considered and unanimously accepted.

6. **Appointed New Trustee in place of Ceased Trustee:**





7. **Retired Trustee:**


- 7.1. **Retired trustees:** On the strength of resolution the Settlor/Trustee/Chairman Sri Jayanta Kumar Biswas, Sri Jhilik Biswas and Sri Tarun Kumar Ghosh have resigned from the Trusteeship. Those Resignations have been accepted in compliance of the provision of the Trust Deed and hence, they are no more the part and parcel of BGD Memorial Trust and/or allied organization whatsoever in relation to the BGD Memorial Trust and thus they became Retired Trustees.

8. **Background Representations and Warranties:**

- 8.1 Approach by the Chairman: The then Chairman of BGD Memorial Trust namely Shri Jayanta Kumar Biswas and one of the Trustees Shri Jhilik Biswas made an approach as a proposal to the present Chairman Sri Tamal Halder to take a charge as Trustee as well as to represent the post as The Chairman of the BGD Memorial Trust to look after its affairs and on acceptance of such proposal, Shri Jayanta Kumar Biswas and Shri Jhilik Biswas unanimously having sound state of mind decided to retire from the constituted body and from trusteeship of BGD Memorial Trust and thereby resolute the construction of further Board with further appointment of new trustees. On the strength of resolution-dated **29.07.2015**, the present Trustees move on to proceed with the Trust affairs.



Barrackpore, Kolkata 760120. The Principal, Bholananda National Vidyalaya represented by **Smt Swati Rudra** wife of Sri Soumya Rudra residing at 237 Ashok Garh, Flat No. 7, Kolkata 700108 and Nominated members of Sree Guru Bholananda Ashram, represented by **Sri Subir Kumar Mitra** son of late Bhola Nath Mitra, residing at Mitralaya, Udayanpally, District North 24 Parganas & **Swami Bhabatmananda Giri** son of late Swami Mahadebananda Giri residing at Sree Guru Bholananda Ashram Monirampore Barrackpore, Post Office: & Police Station: Barrackpore, Kolkata 700120, District North 24 Parganas. have been appointed as New Trustees of said Trust.

9. **Effect:** The effect of resolution dated **29.07.2015** the present Trustees are the New Trustees of BGD Memorial Trust and thus the previous Trustees have got no more functions and/or right in the Trust. The present Trustees in exercise of the Power for the purpose of running Trust affairs as vested upon them by the said Trust Deeds shall follow all the clauses as embodied in the Trust



Deed having every other powers and purpose vested in them by the said Trust Deed and can do with of every other power in this behalf by statute or otherwise then hereunto enabling the present Trustees of the said Trust and/or have given right and/or power to act in all respect jointly on which they have been consented.

10. **Name of the Trust:** The Trust is in existence and/or hereby established was named as **BGD Memorial Trust** by its short abbreviation but its long abbreviation stands/named/known as "**Bholananda Giri Divine Memorial Trust**" (Trust) unless it is amended.


Since, the Settlor proposed by a proposal to amend the name of the BGD memorial Trust to some other name, so, considering his desire, it is further resolved on the strength of resolution as occurred in the Board of Trustees dated 07.02.2016 that the name of the BGD Memorial Trust is required to be amended for some official and/or technical reasons and it was unanimously decided by the Board of Trustees in their meeting dated 07.02.2016 that the name of the said Trust shall be known as "**Sree Guru Bholananda Ashram Trust**" in place of "**Bholananda Giri Divine Memorial Trust**" or BGD memorial Trust unless it is further amended.

It is to mention herein that since, the name of the Trust is now and onwards known as **Sree Guru Bholananda Ashram Trust**, so **Bholananda Giri Divine Memorial Trust** or "**BGD memorial Trust**" shall be treated as Former. Accordingly the Trustees have the liberty to change/record its name in all official papers /documents/Official departments/regulatory/Statutory Bodies whatsoever and also record its all assets whether movable and /or immovable in the amended name as "**Sree Guru Bholananda Ashram Trust**".

11. **Place/Registered Office:** Previously one room as an Office of the Trust was in existence at 205, Ghospara Road, Ghosipara, Post Office Barrackpore, Police Station: Titagarh, Kolkata 700120.

Meanwhile the registered office was shifted temporarily to 56, Barrack Road, P.O & P.S. Barrackpore, Kolkata 700120 and further on the strength of resolution by the Board of Trustees finally the address of the registered office of the instant Trust shifted to **Monirampore, Barrackpore, P.O & P.S. Barrackpore, Kolkata 700120 as permanent registered office** or the Board of Trustees is at liberty to open /shift Office at such other place in India as it may deem fit from time to time.




13. **Corpus:** The then Settlor along with other Trustees have already possessed of and otherwise well and sufficiently entitled to the sum of Rs.10,000/- (Rupees ten thousand only) (**Said Property**), which the Settlor was desired to endow the Trust for different purposes, and accordingly endowed in the year 2001 as hereinafter expressed and contained. It was the desire of the Settlor that the Corpus of the Trust may be further augmented from time to time by flow of funds and other assets including movable and immovable and any other kind by way of Gifts, Donations, acquisitions, allotments, grant exchange, lease, purchase of Land and/or immovable of any nature or otherwise etc. to be utilized for attainment of the Objects of the said Trust and with other Trust if amalgamation of Trust occurs. The BGD Memorial Trust shall have the right to proceed with the amalgamation with other trust or institution or society or organization whatsoever.
14. **Nature of Trust:** The Trust shall engage itself in various charitable activities and businesses for the benefit of all persons belonging to whatever community irrespective of caste, creed or religion, the Trustees shall stand possessed of the Said Property which has already been endowed by the then Settlor and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by way of purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, lease, develop the land property, promotion work for building and rebuilding as multistoried complex or in any other manner (**collectively Trust Properties**).
15. **Accessibility/Jurisdiction:** The accessibility of the Trust with regard to its activities shall remain open in National and International level as the case may be, provided maintaining the provision of Laws/Rules and Regulations and with due permission from the appropriate authority.
16. **Objects:** The objects for which the Earlier Trust being No 1486 for the year 2001 & being no. 05365 for the year 2009 are required to be amended:
- 16.1 **Establish Orphanage and Oldage Home:** To establish Orphanage and Oldage Home for orphans and Old distressed People who are really suffering from different ailments and domestic problems.
- 16.2 **Medical Treatment for Poor:** To provide medical treatment as per the capacity of the Trust to the helpless and poor and distressed people.
- 16.3 **Blood Donation Camp:** To organize Blood Donation camp for a social cause.
- 16.4 **Financial Support to Meritorious Students:** To provide financial support to meritorious students from the economically weak backgrounds.



- 16.5 **Function as Non-Communal Trust:** To function as a Non-communal Trust and as a secular organization.
- 16.6 **Acquire, Develop, Promote and Maintain Property:** To acquire, develop, promote vacant land into multistoried building and maintain the movables and immovable properties for achieving and fulfilling its objects.
- 16.7 **Engage Architect, Engineer etc:** The Board of Trustees shall engage Architect, Engineer, Designer, Scientist, Socialist, Economist, Advisers in different fields and many more as may be required time to time for the smooth functioning of the activities of the Trust.
- 16.8 **Establish and Maintain School, Colleges etc:** To establish, maintain and run schools, colleges, social service centers, training center and allied/vocational educational institutions, play ground, sports complex, and laboratory.
- 16.9 **Promote Education:** To spread its wings in all direction of education and learning in all their fields.
- 16.10 **Train Teachers and Workers:** To train teachers, workers and self help groups in ideals and practice of the true spirit of education and learning.
- 16.11 **Establish Research and Training Centers:** To establish research and training centers for the furtherance of education/learning in its various fields and branches.
- 16.12 **Train and Educate Masses:** To undertake propaganda, training and education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of education in the society.
- 16.13 **Publish Books and Open Library:** To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- 16.14 **Establishment of self-help Groups:** To establish self help group for promoting environmental projects, clean up strategies with regard to polluted water of rivers.
- 16.15 **Grant of Relief:** To grant relief on the occasion of earthquakes, draughts, famine, floods and other occasions of calamities of similar nature or to give donations and/or aid to other institutions or persons doing such relief works.
- 16.16 **Grant of Scholarships, Stipends etc:** To grant scholarships, Stipends, Prizes and such other aid or remuneration to Artists, literalists, musicians, sculptors and such like persons with a view to advancement of national culture or knowledge.
- 16.17 **Grant aid to Centres:** To establish and maintain and to grant aid to centres for diffusions of Indian Art and Culture.

- 16.18 **Other Establishments:** To establish or provide arsenic free tube wells, sanitation and promotion of self-employment generation schemes and to install other programs as may be deemed fit and proper for the time being in force.
- 16.19 **Replacement and Appointment of Other Trustees:** The Board of Trustees may remove or replace the Trustees or appoint other Trustees at any point of time upon their discretion. Such other Trustees appointed in future shall be bound by this Deed of Trust and shall be treated as the Trustees for the purpose of this Deed of Trust.
17. **Term of Office of the Trustees:** The Trustees shall hold the office for such duration as may be specified by the Executive Committee of Sree Guru Bholananda Ashram Trust.
18. **Posts and its Appointment:** Presently the Trustees have jointly decided the name for respective posts to be preceded for the purpose of Trust and the same have been enumerated in the instrument besides the Trustees.
19. **Number Of Trustees, Their Term And Power To Co-Opt:**
- 19.1 **Board of Trustees:** The Trust will be managed by a **Board of Trustees** consisting of not less than 3 Trustees and not more than 15 Trustees for the time being in force. The parties of the Second Part will be First Trustees and they shall automatically form the Board of Trustees.
- 19.2 **Office Term:** The term of office of First Trustees shall be for their respective lives. The Board of Trustees shall have the power to increase the total number of Trustees upto the maximum number stated above and fix their term as per provisions contained herein.
- 19.3 **Retirement:** Any Trustee, including the Managing Trustee may retire from the Trusteeship hereof by giving resignation in writing of his or her intention to do so to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall ipso facto cease to be a Trustee of these presents.
- 19.4 **Vacancy:** Any vacancy caused by death of any one of the First Trustees, or any vacancy caused by the resignation of any of the Trustees, may be filled up by co-option of the Board of Trustees.
- 19.5 **Proceeding:** The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "**Full Board**", subject to the presence of Quorum in the meeting. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

- 19.6 **The day-to-day Administration:** The day-to-day administration of the Trust shall be looked after by Chairman under the guidance, control and supervision of the other Trustees unanimously.
20. **Termination of Office of the Trustees:** A Trustee shall cease to hold office under the following circumstances:
- 20.1 If he dies.
- 20.2 If he resigns.
- 20.3 If he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- 20.4 If he is found to have acted against the interest of the Trust.
- 20.5 If it is decided by the Executive Committee of Sree Guru Bholananda Ashram Trust as stated above that his continuation in the Office is against the interest of the Trust.
21. **Meeting and Proceedings of the Trustees:** The Trustees shall ordinarily meet twice in a year or as often as may be necessary for the satisfactory conduct of the affairs of the Trust and one annual general meeting will be held.
22. **Power:** The Chairman Trustee shall have the power to remove a Trustee suffering from physical or mental disability or if he is accused of misfeasance of Trust funds or property or misconduct, after satisfying himself on enquiry and such action of the Chairman shall be final.
23. **Notice:** 3(three) days Notice shall ordinarily be given in writing for a meeting of the Trustees.
24. **Trust Properties:** The Trust Properties shall vest in the Trust, the Trustees shall manage the whole property and affairs of the Trust and shall have all powers, duties and functions necessary, proper and incidental to the promotion and carrying out of the objects of the Trust. The surplus money if any, will be accounted in favour of the Trust fund.
25. **Powers, Functions and Duties of the Trustees:** In particular and without prejudice to the generality of the foregoing clauses, the Trustees shall for the purposes of the Trust have the following powers, duties and functions:


- 25.1 **Acquire Property for Trust:** To acquire by gift, grant, purchase, exchange, lease, or otherwise, lands, buildings, hospitals or other immovable properties and also any movable property for the Trust and/or the immovable and movable property of other Trust/Society/Institution etc
- 25.2 **Construct and Maintain Buildings:** To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- 25.3 **Accept Donations:** To accept gifts, donations, endowment and contributions for the Trust and shall be treated as the income of the Trust.
- 25.4 **Raise Funds:**
- 25.5 **Raise Finance and others:** To raise loans and advances, to receive moneys, securities or other movable property on behalf of the Trust
- 25.6 **Accept Other Trusts:** To accept any other Trust, Trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of the Trust.
- 25.7 **Award Scholarships:** To award scholarship and make donations to meritorious students.
- 25.8 **Contracts and Engagements:** To enter into contracts, or engagements on behalf of the Trust.
- 25.9 **Sign Documents:** To make, sign and execute all such documents and instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust taking consent of the other Trustees.
- 25.10 **Dispose Trust Properties:** To sell, transfer or otherwise dispose of any of the Trust Properties either movable or immovable provided all the Trustees unanimously resolve that it is in the interest of the Trust to do so to sell or lease, mortgage or otherwise dispose of any of the Trust Properties.

AND it includes the mortgage or hypothecation of trust properties for taking any loan or Advances from Schedule Banks or Financial institutions for the purpose of the fulfilment of the Trust Objects.

AND it further includes the mortgage or hypothecation of the trust properties of the schedule Banks or Financial institutions for the loan advances taken by the other Trusts/Institutions carrying on the similar objectives as of the Trust.



- 25.11 **Appointment of Employees:** To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the Trust and exercise control over all such employees including the power of suspension, dismissal and removal.
- 25.12 **Delegate powers, duties and functions:** To delegate to the employees such powers, duties and functions as are vested in the Trustees.
- 25.13 **Frame Bye-Laws:** To frame bye-laws and such other regulations as are required for achieving its objectives.
26. **Spend the Income of the Trust:** Out of the income of the Trust Properties the Trustees shall be entitled to spend or incur the following expenses namely:
- 26.1 **Pay Taxes:** All rates, taxes, cess, assessments, dues and duties if any payable to the Government, to any municipal or other public bodies in respect thereof or any part thereof.
- 26.2 **Insurance Premium:** The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the Trust Properties.

- 26.5 **Payment to Employees:** Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the Trustees in the carrying out of the function of the Trust.
- 26.6 **Maintenance of Trust Properties:** Cost and expenses of keeping the Trust Properties in good condition.
- 26.7 **Cost of Installations:** Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the Trust Properties.
- 26.8 **Fee of the Professionals:** The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the Trust.
- 26.9 **Other Costs and Charges:** All other costs, charges and expenses of and incidental to the management and administration of the Trust Properties in accordance with the objects and purposes hereof or which may be incidental thereto, after deducting the costs, charges and expenses incurred by the Trustees as aforesaid out of the total gross income received by them from the Trust Properties, the balance that is the net income will be utilized for the objects of the Trust as decided by the Trustees.

- 27.8 **Voluntary Contributions:** To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- 27.9 **Miscellaneous:** To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
- 27.10 **Framing of Rules:** The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
- 27.11 **Restriction:** No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.
